- 01- Bid is valid till required period, Sindh Public Procurement Regulatory Authority | www.pprasindh.gov.pk.
- 02- Bid prices are firm during currency of contract/Price adjustment.
- 03- Completion period offered is within specified limits.
- 04- Bidder is eligible to Bid and possesses the requisite experience, capability and qualification.
- 05- Bid does not deviate from basic technical requirements.
- 06- Bids are generally in order, etc.

*Procuring agency can adopt either of two options. (Select either of them)

- (a) <u>Fixed Price contract</u>: In these contracts no escalation will be provided during currency of the contract and normally period of completion of these works is upto 24 months.
- (b) <u>Price adjustment contract:</u> In these contracts escalation will be paid only on those items and in the manner as notified by Finance Department, Government of Sindh, after bid opening during currency of the contract.
