6.1 Background

Agriculture is Pakistan's largest single sector of the economy, ahead of manufacturing, and accounts for 21.6 percent of the total gross domestic product (GDP). Its share has, however, declined from over 35percent in the early 1970s to 30percent in 1980/81 and 21.6percent at present due to strong growth in the manufacturing and service sectors. The agriculture sector at present employs 17.5 million workers that represents 47.6percent of Pakistan's total labour force. The livelihoods of 62 percent of population (89 million) living in rural areas directly or indirectly depends on agriculture. The latest census indicates that there are 5.1 million farmers with an average farm size of 3.8 hectares which is a decrease from 4.7 hectares and 5.3 hectares in 1980 and 1972, respectively. It has been reported that 69 percent of the farmers are owner-operators as compared to 55percent in 1980 and 42percent in 1972. The agriculture is, therefore, back bone of country's economy contributing over 60percent of foreign exchange earnings.

In general agriculture production has kept pace over the years with increasing demand mainly through horizontal expansion. Yields have remained fairly constant and comparable with those of countries having similar agro-climatic conditions. Production of vegetables, in particular tomatoes and potatoes, has tripled in the last 20 years. The potential for horizontal expansion has, however, been largely exhausted. The need for intensification and modernization of agriculture including improved irrigation techniques has, therefore, become more pressing to satisfy the ever-growing food requirements of the country.

6.2 Present Status of Irrigated Agriculture

Attainment of food security for burgeoning population of the province is the priority policy objective of Government, which has already reached 160 million and it will reach 221 million by 2025 at present growth rate of 1.8 percent. The estimates for demand and production of selected agricultural commodities in 2010 and 2025 under "Lower Demand Scenario" for feeding exponentially growing population are given in the Table below.

The irrigation water requirements of required level of production of 2025 would be 135 MAF against existing availability of 103 MAF at current level of water use efficiency. In addition, the municipal and industrial water demand is expected to increase from 4.1 MAF in 2004 to about

12.1 MAF in 2025, albeit with some return flow to the river system. It is estimated that the shortfall of irrigation water in 2025 will be about 31.39 MAF.

The situation demands immediate steps to enhance agricultural production to ensure uninterrupted food supply in the coming years but water is becoming major limiting factor in achieving this objective. There are 9.1 million hectares of cultivable land in the country that could not be brought under cultivation due to non availability of adequate irrigation water. Although, water resources have been developed during last four decades through construction of dams, canals, and mobilization of groundwater but these developments are not consistent with escalating demand. Consequently, the per capita water availability has declined from 5,650 m³ in 1960 to presently about 1,200 m³. It has been projected that Pakistan would enter in the band of water scarce countries of the world by 2010 when water available per person would be less than 1,000 m³.

On farm water management program has already initiated interventions such as improvement of watercourses in the province under various programms. These initiatives are being successfully implemented and it is expected that improvements being so made will contribute significantly towards enhancing water productivity at the farm level. The proposed project envisages complimenting the efforts for conservation and efficient use of irrigation water. In this project fresh watercourses of non-command area (like lift pumps and tube wells) will be lined maximum for 30% lining of total length of watercourse.

6.3 Project Components and Provisions

For improvement of 545 watercourses following alternatives are proposed.

- 1. Brick Lining.
- 2. Pre-Cast Lining.
- 3. Pipe Lining.

6.4 Project Requirements

6.4.1 Man Power Requirements

As the World Bank Assisted Project-SIAPEP is under execution and most of the staff is engaged with the project, but still On Farm Water Management have sufficient staff to execute this project. Therefore, no need to higher any outside staff for this project.

ABOVE TARGETS ARE TENTATIVE, SUBJECTED TO ADJUSTMENTS ON FIRST COME FIRST SERVE BASIS . THE NUMBER OF WATERCOURSES CAN BE INCREASED/DECREASED DEPENDING UPON THE LENGTH OF WATERCOURSES AND DEMAND OF FARMERS.

FURTHER MODOUS OPERANDI WILL BE ADOPTED

- LANDLORD/OWNER/LEASEE will submit an application for the improvement of their watercourses to Director On farm Water Management Sindh Hyderabad.
- After receiving application alongwith required documents, the same will be marked to the concerned officers for survey of the watercourse and preparation of case folio for approval.
- 3. Field staff will survey the site and prepare the case folio for the watercourse.
- The case folio of watercourse will be submitted to consultants for checking and authentication.
- 5. The Consultants will review the survey and design and made essential correction if feels necessary and approve the design and cost estimation and forward the same to Director On farm Water management Sindh Hyderabad for issuance of final technical sanction.
- 6. Director On Farm water Management will issue Technical Sanction on recommendation of Deputy Director (Field) and Consultants.
- After passing technical sanction for watercourse the concerned landlord/owner/leasee will be asked to start the earth work.
- Consultants along with concerned field staff will check the earth work and issue the earth work certificate.
- Concerned Deputy Director (Field) will submit demand for supply of 40% material to Director On farm water management Sindh for the completion of 1st milestone work.
- After completion of 60% work consultants will again issue completion of 1st milestone certificate and Deputy Director will again demand for supply of the last 40% material to complete the 2nd milestone i.e 100% work.
- After completion of watercourse consultants will be informed for the verification and issuance of FCR(Final Completion Report).

APPENDIX. FINANCIAL NEGOTIATIONS - BREAKDOWN OF REMUNERATION RATES

(Not to be used when cost is a factor in the evaluation of Proposals)

1. Review of Remuneration Rates

- 1.1 The remuneration rates for staff are made up of salary, social costs, overheads, fee that is profit, and any premium or allowance paid for assignments away from headquarters. To assist the firm in preparing financial negotiations, a Sample Form giving a breakdown of rates is attached (no financial information should be included in the Technical Proposal). Agreed breakdown sheets shall form part of the negotiated contract.
- 1.2 The PA is charged with the custody of funds from Government of Sindh and is expected to exercise prudence in the expenditure of these funds. The PA is, therefore, concerned with the reasonableness of the firm's Financial Proposal, and, during negotiations, it expects to be able to review audited financial statements backing up the firm's remuneration rates, certified by an independent auditor. The firm shall be prepared to disclose such audited financial statements for the last three years, to substantiate its rates, and accept that its proposed rates and other financial matters are subject to scrutiny. Rate details are discussed below.

(i) Salary

This is the gross regular cash salary paid to the individual in the firm's home office. It shall not contain any premium for work away from headquarters or bonus.

(ii) Social Costs

Social costs are the costs to the firm of staff's non-monetary benefits. These items include, *inter alia*, social security including pension, medical and life insurance costs, and the cost of a staff member being sick or on vacation. In this regard, the cost of leave for public holidays is not an acceptable social cost nor is the cost of leave taken during an assignment if no additional staff replacement has been provided. Additional leave taken at the end of an assignment in accordance with the firm's leave policy is acceptable as a social cost.

(iii) Cost of Leave

The principles of calculating the cost of total days leave per annum as a percentage of basic salary shall normally be as follows:

Leave cost as percentage of salary $1 = \frac{total \ days \ leave \ x \ 100}{[365 - w - ph - v - s]}$

¹ Where w = weekends, ph = public holidays, v = vacation, and s = sick leave.

It is important to note that leave can be considered a social cost only if the PA is not charged for the leave taken.

(iv) Overheads

Overhead expenses are the firm's business costs that are not directly related to the execution of the assignment and shall not be reimbursed as separate items under the contract. Typical items are home office costs (partner's time, nonbillable time, time of senior staff monitoring the project, rent, support staff, research, staff training, marketing, etc.), the cost of staff not currently employed on revenue-earning projects, taxes on business activities and business promotion costs. During negotiations, audited financial statements, certified as correct by an independent auditor and supporting the last three years' overheads, shall be available for discussion, together with detailed lists of items making up the overheads and the percentage by which each relates to basic salary. The PA does not accept an add-on margin for social charges, overhead expenses, etc., for staff who are not permanent employees of the firm. In such case, the firm shall be entitled only to administrative costs and fee on the monthly payments charged for subcontracted staff.

(v) Fee or Profit

The fee or profit shall be based on the sum of the salary, social costs, and overhead. If any bonuses paid on a regular basis are listed, a corresponding reduction in the profit element shall be expected. Fee or profit shall not be allowed on travel or other reimbursable expenses, unless in the latter case an unusually large amount of procurement of equipment is required. The firm shall note that payments shall be made against an agreed estimated payment schedule as described in the draft form of the contract.

(vi) Away from Headquarters Allowance or Premium

Some Consultants pay allowances to staff working away from headquarters. Such allowances are calculated as a percentage of salary and shall not draw overheads or profit.

(vii) Subsistence Allowances

Subsistence allowances are not included in the rates, but are paid separately and in local currency. No additional subsistence is payable for dependents—the subsistence rate shall be the same for married and single team members.

Standard rates for the particular country may be used as reference to determine subsistence allowances.

2. Reimbursable expenses

2.1 The financial negotiations shall further focus on such items as out-of-pocket expenses and other reimbursable expenses. These costs may include, but are not restricted to, cost of surveys, equipment, office rent, supplies, international and local travel, computer

rental, mobilization and demobilization, insurance, and printing. These costs may be either unit rates or reimbursable on the presentation of invoices, in foreign or local currency.

3. PA Guarantee

3.1 Payments to the firm, including payment of any advance based on cash flow projections covered by a PA guarantee, shall be made according to an agreed estimated schedule ensuring the consultant regular payments in local and foreign currency, as long as the services proceed as planned.

1. GENERAL PROVISIONS

- **1.1 Definitions** Unless the context otherwise requires, the following terms whenever used in this Contract have the following meanings:
 - (a) "Applicable Law" means the Sindh Public Procurement Act, thereunder Rules 2010.
 - (b) "Procuring Agency PA" means the implementing department which signs the contract
 - (c) "Consultant" means a professional who can study, design, organize, evaluate and manage projects or assess, evaluate and provide specialist advice or give technical assistance for making or drafting policies, institutional reforms and includes private entities, consulting firms, legal advisors, engineering firms, construction managers, management firms, procurement agents, inspection agents, auditors, international and multinational organizations, investment and merchant banks, universities, research institutions, government agencies, nongovernmental organizations, and individuals.
 - (d) "Contract" means the Contract signed by the Parties and all the attached documents listed in its Clause 1, that is General Conditions (GC), the Special Conditions (SC), and the Appendices.
 - (e) "Contract Price" means the price to be paid for the performance of the Services, in accordance with Clause 6;
 - (f) "Effective Date" means the date on which this Contract comes into force and effect pursuant to Clause GC 2.1.
 - (g) "Foreign Currency" means any currency other than the currency of the PA's country.
 - (h) "GC" means these General Conditions of Contract.
 - (i) "Government" means the Government of Sindh.
 - (j) "Local Currency" means Pak Rupees.
 - (k) "Member" means any of the entities that make up the joint venture/consortium/association, and "Members" means all these entities.
 - (l) "Party" means the PA or the Consultant, as the case may be, and "Parties" means both of them.

- (m) "Personnel" means persons hired by the Consultant or by any Sub-Consultants and assigned to the performance of the Services or any part thereof.
- (n) "SC" means the Special Conditions of Contract by which the GC may be amended or supplemented.
- (o) "Services" means the consulting services to be performed by the Consultant pursuant to this Contract, as described in the Terms of References.
- (p) "Sub-Consultants" means any person or entity to whom/which the Consultant subcontracts any part of the Services.
- (q) "In writing" means communicated in written form with proof of receipt.

1.2 Law Governing This Contract, its meaning and interpretation, and the relation between the Parties shall be governed by the applicable law.

- **1.3 Language** This Contract is executed in the language specified in the SC, which shall be the binding and controlling language for all matters relating to the meaning or interpretation of this Contract.
- 1.4 Notices 1.4.1 Any notice, request or consent required or permitted to be given or made pursuant to this Contract shall be in writing. Any such notice, request or consent shall be deemed to have been given or made when delivered in person to an authorized representative of the Party to whom the communication is addressed, or when sent to such Party at the address specified in the SC.
 - 1.4.2 A Party may change its address for notice hereunder by giving the other Party notice in writing of such change to the address specified in the SC.
- 1.5 Location The Services shall be performed at such locations as are specified in special condition of contract and, where the location of a particular task is not so specified, at such locations, whether in the Government's country or elsewhere, as the PA may approve.

1.6 Authority of In case the Consultant consists of a joint venture/ consortium/ association Member in of more than one individual firms, the Members hereby authorize the individual firms or specified in the SC to act on their behalf in exercising all the Consultant's rights and obligations towards the PA under this Contract, including without limitation the receiving of instructions and payments from the PA.

If the PA determines that the Consultant and/or its Personnel, sub-contractors, sub-consultants, services providers and suppliers has engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices, in competing for or in executing the Contract, then the PA may, after giving 14 days notice to the Consultant, terminate the Consultant's employment under the Contract, and may resort to other remedies including blacklisting/disqualification as provided in SPPR 2010.

Any personnel of the Consultant who engages in corrupt, fraudulent, collusive, coercive, or obstructive practice during the execution of the Contract, shall be removed in accordance with Sub-Clause 4.2.

Integrity Pact

- B. If the Consultant or any of his Sub-consultants, agents or servants is found to have violated or involved in violation of the Integrity Pact signed by the Consultant as Appendix-G to this Form of Contract, then the Client shall be entitled to:
 - recover from the Consultant an amount equivalent to ten times the sum of any commission, gratification, bribe, finder's fee or kickback given by the Consultant or any of his Sub-consultant, agents or servants;
 - (b) terminate the Contract; and
 - (c) recover from the Consultant any loss or damage to the Client as a result of such termination or of any other corrupt business practices of the Consultant or any of his Sub-consultant, agents or servants.

(b) If the PA finds that any of the Personnel have (i) committed serious misconduct or have been charged with having committed a criminal action, or (ii) have reasonable cause to be dissatisfied with the performance of any of the Personnel, then the Consultant shall, at the PA's written request specifying the grounds thereof, provide as a replacement a person with qualifications and
