The Government of Sindh intends to take-up 4204 Schools for Rehabilitation & Expansion of facilities in various Districts of Sindh. These 4204 Schools lacks basic facilities. In order to streamline and ensure speedy provision of basic facilities, School Education & Literacy Department has introduced high priority programme wherein boundary wall, toilets, drinking water & Electricity and additional classrooms are to be provided starting in Financial Year 2017-18 in all Districts as per established criteria and guidelines.

SCOPE OF SERVICES

Implementation Unit (IU) invites the expressions of Interest (EOI) from renowned / well reputed Engineering consultants and Project Management firms / companies to provide the following services.

- Sequence visits to be taken in collaboration with School Education & Literacy Department Engineering Staff of Education Works.
- Provide support to IU to mobilize the contractor at site and where required ask Contractors to develop contour maps of site;
- Ensure that the facility is constructed in accordance with engineering standards as per approved design;
- Support Head Masters / Headmistress in construction of missing facilities in 4204 schools all over Sindh Province.

The services are required initially for one year and expected to continue for further 02 years upon satisfactory performance. More than 01 consultant will be engaged to cover Sindh Province, which is administratively divided in 06 regions i.e (Karachi, Hyderabad, Benazirabad, Mirpurkhas, Sukkur and Larkana).
