Bidders Qualification / Eligibility Criteria:

6. Bidding documents will be issued only to the Bidders who shall strictly qualify the eligibility criteria as under:
- i. Registration with Pakistan Engineering Council in the relevant category or above discipline of Bid Cost.
 - ii. For Electric works valid licence issued from Inspectorate of Electrical Licence, Government of Sindh of the similar region with respect to works shown above will be considered.
 - iii. Specialization of work in the concerned field and registration with PEC according to the value of tenders (in original) including documentary evidence regarding under completion / completed works along with satisfactory completion certificate from the concerned department. List of on-going works with details and work order.
 - iv. List of available machinery / equipment.
 - v. Turnover of last 3 years in the shape of Bank statement from any scheduled Bank equivalent to Bid cost and having 20% amount available as the balance in the Bank Accounts with respect to Bid cost.
 - vi. Valid registration with Federal Board of Revenue (FBR) for Income Tax (NTN).
 - vii. Valid registration with the Sindh Revenue Board (SRB).
 - viii. The Bid Security 5% (five percent) of Bid amount in the shape of call deposit / pay order issued from any scheduled Bank of Pakistan in favour of concerned Executive Engineer, Education Works District Central Karachi shall be submitted at the time of submission of Bidding Documents.
 - ix. Full name, complete address, telephone number, fax number, e-mail of the organization.
 - x. Copy of CNIC of proprietor / partners (if any).
 - xi. Undertaking on stamp paper of Rs. 200/= that firm is not involved in any litigation, Departmental Rift or has left the previous work awarded or un-necessary delay in completion of any work in the Education Works or in other Departments.
 - xii. Undertaking on stamp paper regarding Non-Black Listing of firm previously be Government's Semi-Governments and Autonomous Bodies.
 - xiii. Undertaking regarding list of Partners / Partnership Deed with Directors / Proprietors etc. with complete information along with Power of Attorney / Sole Proprietor.
 - xiv. Undertaking on stamp paper that information submitted by Bidder / Firm is correct if found misleading at any stage the work awarded will be cancelled.
 - xv. In case of holiday and unforeseen circumstances on opening date, the bids shall be **submitted and opened on the next working day**. Other terms and conditions shall remain the same.
 - xvi. Incomplete / conditional Bids will not be entertained and will be rejected out rightly.
