2. The Bid / Tender Should be accompanied by a Pay Order of any schedule Bank equivalent to minimum 2% of the quoted amount as bid security, failing which Bid / Tender will be not be entertained.
3. Bid Security of a bidder will be fore feted if on declaration of him being successful, he fails to submit acceptable performance bond and / or fails to sign / provide agreement papers and agreement with in the prescribed time given in the bid documents. Further more, in this event, he may be disqualified from further bidding process.
4. The Bids / Tenders will be received in the office of the Staff Engineer, LDA in Sector 30, in Hawksbay Scheme -42, Karachi on 22-10-2009 upto 1.00 PM and opened on the same day at

02.00 PM. In case bids / Tender submission / opening day is declared a holiday, the same will be received / opened on the next working day or any other day notified.

5. LDA may reject all or any bids subject to relevant provision of PPRA Rules.
6. Bids / Tenders with any conditions shall be rejected.
