**INVITATION FOR PRE-QUALIFICATION.**

The Irrigation & Power Department has been entrusted by the Government of Sindh to execute project of Rehabilitation of Old X-Regulators along Rohri Main Canal in Rohri Canal Circle Hyderabad. The project will be financed through funds provided by Government of Sindh. The contract, for which this invitation for prequalification is being issued, is named as "Rehabilitation of Old X-Regulators along Rohri Main Canal".

**BACK GROUND.**

All the original old X-Regulators were constructed in the year 1931 on Bligh's creep theory hence all structures are more than 75 years old. These structures were constructed with lengthy floors. After passing such long period it is presumed that the material used has lost its strength, which could at any time may cause damage to the Structures.

1. The Superintending Engineer Rohri Canal Circle Hyderabad with Phone No. 022-9200278 & Fax No. 022-9200277 intends to pre-qualify local constructors for National Competitive Bidding (NCB) for the works under this project, mentioned in the documents which include but not limited to the following.
2. It is expected that Invitation to Bid will be issued by the Superintending Engineer Rohri Canal Circle Hyderabad.
3. Pre-qualification is open to constructors / joint ventures of constructors who are registered with PEC in category "C-2 upto 200 Million" as per re-categorization of the revised financial limits (effective January -2008) for Construction and Operation of Engineering Works. Applications may be submitted for prequalification for the said works.
4. Appropriate category PEC registered Constructors may obtain the prequalification documents from the office of the undersigned or may request to send the same through mail at the specified address.
5. The request must clearly state "Request for Pre-qualification Documents" for Rehabilitation of Old X-Regulators along Rohri Main Canal. The documents available for a non refundable fee of Rs. 2000/- from issue of this letter upto 07.11.2009 onward during office hours. The documents if requested by mail will be promptly dispatched by registered mail for which cost of mail Rs. 250/- will be borne by the applicant, however, under no circumstances the employer will be responsible for late delivery or loss of documents so made.
