2. No conditional tenders will be accepted.
3. The tenders will be received back on 13/01/2010 and will be opened on same day at 1.0 PM in the presence of tender opening committee / evaluation committee and bidders or their authorized representative who wish to be present at that time.
4. If the undersigned happens to be out of head quarter or Govt. announces it a public holiday on the date of opening of tender, the same will be opened on next working day at 1.00 PM.
5. If the tenders went unresponsive then the next dates for receiving / opening tenders will be 19<sup>th</sup> January 2010 and 26<sup>th</sup> January 2010.
6. The procuring agency may reject all or any bids subject to the relevant provisions of PPRA Rules.
