EXPRESSIONS OF INTEREST REGARDING CONSULTANCY SERVICES FOR CONSTRUCTION / INSTALLATION OF GARBAGE TRANSFER STATION (GTS) AT MEWA SHAH, SITE TOWN.

The CDGK intends to construct a Garbage Transfer Station (GTS) at Mewa Shah, SITE Town to handle the waste quantity of 2000 tones daily.

To select optimal, technical and financial feasible solution for the transportation of waste from Mewa Shah to Jam Chakro landfill site at Surjani Town (25 km hauling distance one way). CDGK invites competent local or internationally experienced and well reputable consultant / consortium to express their interest in providing the pre-feasibility study, design and operational mechanism for the G.T.S project that includes:

- 1. Analysis and Waste characterization.
- G.T.S design (Equipment specification and detailed designs of civil works, utilities and electrical installations) with detailed cost estimates of investments and operations.
