

- Tender documents will strictly be issued to the contractor / firm whose past performance is satisfactory and on submission of written applications on their original letter head personally to EDO W&S, CDGK along with the original & attested evidence on their valid enlistment / renewal / registration with Pakistan Engineering Council on payment of non-refundable cost of tender price through pay order from any schedule bank in favour of CDGK and also depositing a 2% Pay Order / Bank Guarantee of Earnest Money in favour of CDGK of an amount as mentioned above.
- The contractor must mention their complete and correct present postal address in tender documents & quote the rates both in words & in figures. Incomplete / Conditional tenders will not be accepted.
- The contractors shall have to deposit the balance 2% Earnest Money for total bid (Refundable after finalization of tenders except the 1<sup>st</sup> lowest bidder) in the shape of pay order / Bank Guarantee of

any schedule Bank, drawn in favour of CDGK, with the tender documents otherwise the tender will be treated as cancelled.

5. In case of non participation in any of the above schemes, the tenders can be dropped upto 15-02-2010 at 02:00pm on the time as mentioned above and will be opened on the same day at 02:30pm. The documents in case non participation can be purchased upto 13-02-2010.
6. In case the date of opening declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.
7. The Competent Authority reserves the right to accept any or reject any or all tenders subject to the relevant provision of PPRA Rules.
8. Earnest money of bid amount in the form of a pay order or in shape of unconditional Bank Guarantee in favour of CDGK should be enclosed with the tender which will be retained till finalization of the case.
9. Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who report canvassing will liable for rejection.
10. Tenders in unsealed covers will not be entertained.
11. Tenders will not be received after the schedule time.
