The cost of Equipments quoted on CIF Basis will be calculated on exchange rate (Buying) at the day of opening tender.

Prescribed tender proforma alongwith copy of terms and conditions can be obtained on the payment, mentioned in the above schedule against pay order (Non Refundable) in the favour of EDO Health, CDGK & on production of following documents from the office of EDO Health CDGK 6th Floor Civic Center, Karachi (ii) EDO Finance and Planning Department, CDGK 6th floor Civic Center Karachi and (iii) District Officer Medical Services near Islamia College Karachi (iii) Executive Director, Karachi Institute of Heart Diseases CDGK on any working day.

The bidding shall be on "Single Stage- Two envelope procedure":-

- 1st Envelope should contain Technical proposal only and be clearly marked "Technical Proposal".
- 2. 2nd Envelope should contain Financial Proposal" (Rates on CIF & FOR basis) alongwith earnest money @ 2 percent of the quoted rates in the shape of pay order / demand draft (refundable to unsuccessful bidders) the envelope be clearly marked as "Financial Proposal". Alternatively Rs. 5,00,000/- as lump sump in shape of pay order/demand draft in favour of CDGK may be submitted and sealed in a separate envelope.
- Both Envelopes should be sealed separately and placed in a 3rd Envelope. The name of the bidder be clearly marked on all envelopes.

Tender should be dropped in the tender box kept in the office of the EDO (Health) CDGK @ 6^{th} Floor Civic Center, Karachi at 1.30 P.M. on 10-02-2010.

The Technical Proposals of bids shall be opened publicly at 2.00 P.M. on 10-02-2010 in presence of bidders or their nominated representatives who wish to attend.

After the evaluation and approval of the **Technical Proposal of equipment / instruments on the basis of Technical Literature/Brochure/documents and Demonstration of Equipments/Instruments,** the CDGK shall at time within the bid validity for minimum of 60 days publicly open the **Financial Proposals** of the technically accepted bids only. The financial proposal of bids found technically non responsive shall be returned un-opened to the respective bidders.

The procuring agency may reject all or any bids subject to the relevant provisions of PPRA Rules.

The Government notified black listed firms / suppliers shall not be entertained.

The Competent Authority may select any one or none of the System on the basis of recommendations of Technical Committee/Central Purchase committee, CDGK.

Tenders which do not fulfill the terms & Conditions will not be entertained.

In case the tender is not opened on schedule dates due to any force de majure then the same shall be opened on next working day.
