In case of any reason, if the tenders are not responded on the above dates the next date of submission and opening will be 25-02-2010 and the tender documents will also be available for sale from 17-02-2010 to 24-02-2010.


In Case the date of opening declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the time as mentioned above.

The total bid amount as well as the rates of items must be filled both in figures and words and in case any correction made by the contractor himself then each correction must be initialed by the Contractor, otherwise the tenders are liable to be summarily rejected.

2% earnest money in the form of a pay order should be enclosed with the tender which will be retained till finalization of the case.

Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who are reported canvassing will be liable for rejection.
