In case of any reason, if the tenders are not responded on the above dates the next date of submission and opening will be ~~25-02-2010~~ and the tender documents will also be available for sale from ~~17-02-2010 to 24-02-2010~~.

In Case the date of opening declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the time as mentioned above.

The total bid amount as well as the rates of items must be filled both in figures and words and in case any correction made by the contractor himself then each correction must be initialed by the Contractor, otherwise the tenders are liable to be summarily rejected.

2% earnest money in the form of a pay order should be enclosed with the tender which will be retained till finalization of the case.


The bidders while submitting their bids are also required to enclose the documents regarding the following for their responsiveness against the work prior to their financial evaluation.

2. Works of similar nature and size performed in last 3 years.
3. List of construction equipment.
4. List of Technical staff.
5. Financial Statement of last 3 years.
6. Information regarding litigation and abandoned works if any.

If any fake documents found then CDGK is liable to reject / cancel the tender / work without any compensation and penalize as per rules.

Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who are reported canvassing will be liable for rejection.

The procuring agency may reject all or any bids subject to the relevant provisions of PPRR Rules.
