- 3. The tenders will be received back on 03/04/2010 and will be opened on same day at 1.0 PM in the presence of tender opening committee / evaluation committee and bidders or their authorized representative who wish to be present at that time.
- 4. If the undersigned happens to be out of head quarter or Govt. announces it a public holiday on the date of opening of tender, the same will be opened on next working day at 1.00 PM.
