

2. The tenders will be received back on **15.06.2010** upto 1.00 PM and opened on the same day at 2:00PM in the presence of tender opening/evaluation committee and the bidder or their authorized representatives who wish to be present.
3. If due to some certain official activities, the undersigned is out of headquarter, or in case the tenders are cancelled/ rejected or un-responded, the next dates for issue and opening will be as under.
 - a. Date of Issue on **17.06.2010** upto 1:00 PM, received back on same Day upto 2:00 PM & will be opened after half an hours.

 - g. Finance stability certificate issued by a scheduled Bank.

 - i. Affidavit in which it should be undertaken that the information/particulars provided by him is true and correct.


