NOTICE INVITING TENDERS.

SEALED TENDERS ON B-I AGREEMENT FORM (PERCENTAGE RATE) ARE INVITED FROM THE INTERESTED PERSONS / SUPPLIERS / CONTRACTORS / COMPANIES, AS PER WORK'S LIST ATTACHED UNDER PPRA RULES 2004.

1. The intended participants can purchase the separate set of tenders on payment of tender fee for each work upto 2:00 P.M, on **22-07-2010**.
2. The tenders shall be opened on 23-07-2010 at 4:00 P.M., in the presence of tender opening / evaluation committee and bidders or their authorized representatives who wish to be present.
3. Eligibility conditions for intending participants are as under:-
 - i. Registration with Pakistan Engineering council in the relevant field of specialization of work and to the extent of tender amount of each work.
 - ii. Bio date of Engineers and technical staff working with the firm.
 - iii. Documentary evidence of works executed / works in progress and certificate of satisfactory completion of works by the employers.
 - iv. List of works in progress indicating cost of each work and copy of letter of award of work.
 - v. List of machinery and equipment available with documentary evidence of its ownership certificates of Bank showing credit worthiness alongwith Bank statement.
4. Registration with Income Tax Department (NTN Certificates) and copy of N.I.C.
5. Under Taking on Affidavit that firm is not involved in any litigation or abandoned any work in the department.
6. The bidders should submit earnest money as shown against each work in shape of call deposit prepared from the scheduled bank in favour of the undersigned.
7. Affidavit to the effect that the Firm / Contractor have not been black listed previously by any executing agency.
8. Affidavit with effect that all documents / particulars / information furnished are true & correct.
9. In case of firm, list of partners / partner ship Deed, giving full particulars of Director / Proprietors or others connected along-with Power of Attorney. In case of being sole proprietor such undertaking on affidavit be furnished.
10. In case of works costing below Rs.2.500 (M) the conditions @ S.No.3 will not be applicable.
11. The procuring agency may reject all or any bids subject to the relevant provisions of PPRA Rules.
12. The 2nd date of issuance upto **02-08-2010** and opened of tender will be on **03-08-2010**.


