Tender documents will strictly be issued to the contractor / firm whose past performance is satisfactory and on submission of written applications on their original letter head personally to District Officer-I(Keamari Package), CDGK along with the original & attested evidence on their valid enlistment / renewal / registration with Pakistan Engineering Council on payment of non-refundable cost of tender price through pay order from any schedule bank in favour of PD (Keamari Package), CDGK of an amount as mentioned above.

3. The contractor must mention their complete and correct present postal address in tender documents & quote the rates both in words & in figures. Incomplete / Conditional tenders will not be accepted.
4. The contractors shall have to deposit the 2% Bid Security for total bid (Refundable after award of work and signing of contract with the successful bidder) in the shape of pay order drawn in favour of PD (Keamari Package), CDGK with the tender documents otherwise the tender will be treated as cancelled.
5. In case of any reason, if the tenders are non responded on the above dates the next date of submission and opening will be 30-08-2010 and the tender documents will also be available for sale upto 27-08-2010.
6. In case the date of opening declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.
