4. After Technical Evaluation, envelope of “Commercial Proposal” of technically acceptable bidders will be opened with prior intimation to successful bidder(s). The Commercial proposal of bids found technically non-conforming will be returned Unopened to the respective bidder as per SPPRA RULES 2010.
