Bid Security in shape of pay order from any schedule Bank in favor of CDGK as mentioned above should be enclosed with the bid otherwise the tender will be rejected. No tender will be sold on the tender opening date.

The tender in sealed cover superscripted with the name of work should be dropped in the tender box kept in the office of the Executive District Officer (Works & Services) 4th Floor, Civic Center, University Road, Gulshan-e-Iqbal, Karachi by 2:00 pm on 02-12-2010 and the same will be opened on the same day at 2:30 pm in the Committee Room of Works & Services Department, CDGK 4th Floor, Civic Center, University Road, Gulshan-e-Iqbal, Karachi in presence of those bidders or their representative who wish to be present.

4. In case of any reason, if the tenders are not responded on the above date the next date of submission and opening will be 09-12-2010 and the tender documents will also be available for sale upto 08-12-2010.

5. In case the date of opening is declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the same time as mentioned above.

6. The total bid amount as well as the rates of items must be filled both in figures and words and in case any correction is made by the contractor himself then each correction must be initialled by the contractor; otherwise the tenders are liable to be summarily rejected.

Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who are reported to be involved in canvassing will be liable for

rejection.

If a bidder submits a seriously unbalanced bid then if deemed necessary, the procuring agency may require him to deposit extra performance security to a level sufficient to protect the procuring agency against financial loses, failing which the submitted bid security will be forfeited by the procuring agency.

Bid security of the unsuccessful bidder shall be released once the contract has been

signed with the successful bidder or the validity period has expired.
