Term of Reference

The consultant will carry out detailed site condition surveys, conduct ground, GPS, Arial satellite surveys and in addition where ever investigation required for the preparation of engineering estimate and further survey will be suggested accordingly subject to the availability of funds or if deemed necessary funds will be arranged accordingly.

Consultant will also conduct initial socials and environment assessments as per criteria and if necessary suggested the mitigation measure to address the respective issues.

The consultant will suggest the economical, sustainable, ensured options and proposed the best alignment of the said channel and get approval from competent authority. The detailed designs, and specification and estimate of costs for the work will be incorporated in PC-I subject on the approval of the competent authority.


The project Director will procure the necessary field equipment, satellite images or any other relevant materials which will be required for the work.
