The pre-qualification documents are available for a non refundable fee of Rs. 2000/- from 10:00 A.M onwards during office hours.

- v. Details of works of similar nature worth minimum value of Rs. 100.00 Million or above already completed during last 3 years or in hand awarded by Irrigation and Power Department supported by satisfactory completion certificate.
- vi. Details of earth moving machinery and transport in good order owned by the firms / contractors.
- vii. Income tax registration and clearance certificate.
- viii. Financial status showing current assets and current liabilities duly authenticated.
- ix. The contractors / firms should submit annual bank statement / annual turn over for last 3 years.
- x. Solvency certificate issued by the Bank for Rs. 50.00 million or above.
4. An affidavit giving status of any dispute / arbitration of civil suites.
5. Any false information given by contractor / firm shall result in disqualification.
6. Payment made to the contractors / firms is further subject to availability of funds.
7. The contractors / firms having sufficient experience in above four types of civil works will only be considered for pre-qualified.
8. The Chief Engineer Irrigation Gudu Barrage Region Sukkur reserve the right to accept or reject late applications without assigning any reason thereof.
9. Applicant will be informed in due course of the result of evaluation of applications. Only the firms / contractors pre-qualified under this process will be invited to bid.


