

4. Earnest money at 2% in the shape of call deposit of any Scheduled Bank duly pledged in the name of the undersigned should be attached with the application for receiving the tenders. No tender form will be issued without Call Deposit.
5. Intending contactors will have to give documentary proof of their experience in similar kind of works in appropriate category.
6. The said works will be executed during the Annual Closure of 2010-2011 and the time period available for the works mentioned above is only the Annual Closure Period of Sukkur Barrage, which is expected to start from 6th January 2011 up to 20th January 2011. The successful contractors will be required to mobilize well in advance so as to carry out the work within the stipulated period. The contractor, to whom the work is awarded, will be responsible to recoup the damage if any, caused to the incomplete work and he will have to complete the same at his own risk and cost.
