
**RE-TENDER NOTICE**

1. The Sealed tenders are invited from suppliers /contractors for supply of cooked food to the under trial Prisoners confined in judicial and Police lockups District Umerkot through a registered post or by hand on 29-12-2010 before 1:00 pm in the office of the Executive District Officer (Revenue) Umerkot for a period of 12 months commencing from July 2010 to June 2011.
2. The scale of diet to be provided to the prisoners will be in accordance with the provisions as laid down in chapter 20 of Pakistan Prison Rules as amended from time to time.
3. The simple tender application/form should be addressed to the Executive District Officer (Revenue) Umerkot.
4. The tender/application must reach in the Office of EDO (Rev) Umerkot at 1:00 pm on. 29-12-2010 in a sealed envelop and the same received by post after that time will not be accepted.
5. The earnest money at 2.5% of the value of Rs.10, 00,000/= must be furnished as security deposit by successful bidder.
6. The successful contractor will not claim any enhancement of rate at any stage during period of contract.
7. The successful suppliers/contractors are required to make agreement with superintendent of the lockup before the start of supply of cooked food to the prisoners.
8. The contract once granted will not be transferable.
9. The tender committee will open the tender on 29-12-2010 at 1:30PM in presence of contractors, who wish to be present on the day. In case, the chairman or any member of the committee would be out of the headquarter on the date, the tender will be opened on the next date on his return to headquarter.
