- 3. The tender shall be opened on 13.01.2011 at 14:30 in presence of Purchase Committee and in presence of representatives of bidders who choose to be present on the occasion, in the Committee Room of Central Police Office, Sindh, Ground Floor, I.I.Chundrigar Road, Karachi.
