NOTICE FOR PREQUALIFICATION

Applications are invited for prequalification of Contractors/Firms for execution of Flood Protection Civil Works along River bund /Canals in Sukkur Barrage Right Bank Region Larkana. The works will comprise of the following major types:-

- i). Earth work
- ii). Laying of stone pitching
- Construction of flood protective structures.
- Pre-qualification is open to Contractors/Firms who are registered with Pakistan Engineering Council in Category C-3 and above for Construction and Operation of Civil Engineering Works as well as technically and financially capable Firms/Contractors having adequate managerial capability may apply for prequalification for the above major type of works.
- Appropriate category of Pakistan Engineering Council registered Contractors/firms may obtain prequalification documents from office of the Chief Engineer Sukkur Barrage Right Bank Region Larkana. The prequalification documents are available for a non-refundable fee of Rs.2000/- from 10.00 am onwards during office hours.
- Application for prequalification must be delivered in sealed envelope by hand or through courier services to the Chief Engineer Sukkur Barrage Right Bank Region Larkana not later than 08-01-2011 at 11.00 hours with the following information :-
 - Name, Address, Telephone / Cell #, Telegraphic / Telex Code and Email Address.
 - Copy of License issued by the Pakistan Engineering Council Islamabad for the year 2010 - 2011.
 - Bio-data of technical personnel available full time with the Contractors/Firms.
 - General Information about the firm, i.e its date of establishment, name of principle, date of registration etc:
 - Details of works of similar nature worth minimum value of Rs.100 Million or above already completed during last three(3) years supported by satisfactory completion certificate.
 - Details of Earth moving machinery and transport in good order owned by the Contractors/Firms.

- g Income Tax Registration and Clearance Certificate.
- h. Financial Status showing current assets and current liabilities duly authenticated.
- j. The Contractors/Firms should submit Annual Bank Statement / Annual Turn Over for last three(3) years.
- k. Solvency Certificate issued by the Bank for Rs.50 Million or above.
- 4. An affidavit giving status of any dispute or arbitration of Civil Suit.

 Any false information of Civil Suit.
- 5. Any false information given by the Contractors/Firms shall result in disqualification.
- 6. Payment made to the Contractors/Firms is further subject to availability of
- 7. The Contractors/Firms having sufficient experience in above four(4) types of Civil Works will be only be considered for pre-qualification.
- 8. The Chief Engineer, Sukkur Barrage Right Bank Region reserved the right to accept or reject late application without assigning any reason thereof.
- 9. Applicant will be informed in due course of the result of evaluation of applications. Only the Contractors/Firms pre-qualified under this process will be invited to bid.
