6. Substantially Responsive Bid:-

Only those bids, which comply with the requirements uploaded separately on CDGKs' Website and attached with the tender documents shall be declared substantially responsive bids at the time of tender opening and will be eligible for further evaluation, otherwise the same will be declared as non-responsive / rejected.

- The bidders are required to submit the above information, the signed evidence against evaluation criteria along with their bids. However Joint Venture between two or more firms is allowed subject to compliance of conditions of stipulated rules of PEC.
- If any fake documents are found then the tender is liable to be rejected/cancelled with out any compensation and with penalty as per rules.
- Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who are reported convassing will be liable for rejection.
- 10. It a labeler autually a sectionally unfullmental bid then be will be required to deposit extra performance as milly to a level sufficient to protect the procuring agency against financial losses, failing which the submitted bid security will be forfeited by the procuring agency.

- Bid Security as mentioned in the NIT & Bidding Documents is furnished.
- All rates quoted including the total amount of the bid shall be in figures & words (both).
- iii). All corrections / overwriting shall be clearly re-written with initials & duly stamped by the bidder.
- iv). The bid shall be properly signed, named & stamped by the authorized person of the firm and authorization letter for signatory shall be enclosed with the tender by the authorized person.
- v). Evidence of employing and Engineer as declared in the PEC License should be provided in shape of copy of Engineer's Registration certificate by PEC, Bank Statement showing the name and amount of the monthly salary of the Engineer / Paid copy of the Income Tax challan in the name of the Engineer of the salary is taxable.
- vi). Bank certificate (original) in respect of financial capability / credit limit of the bidder not less than 30% of the bid amount issued on or after 15th January 2011 should be produced.
- vii). The evidence of ownership/lease of related road construction Machinery (at least 2 numbers) to the bidder.
- viii). The minimum turn over / work experience with satisfactory completion report in last 2 years should be equal to the work cost in which bidder interested its participation.
