

Invitation for Bids
Loan 2499-PAK Sindh Cities Improvement Investment Program – Project 1
Contract No. PE-01 Procurement of Priority Equipment

1. The Islamic Republic of Pakistan has received a loan from the Asian Development Bank (ADB) toward the cost of Sindh Cities Improvement Investment Program – Project 1, and it intends to apply part of the proceeds of this loan to payments under the contract for Procurement of Priority Equipment, Contract No. PE-01.
2. The North Sindh Urban Services Corporation (NSUSC) now invites sealed Bids from eligible Bidders for the goods and related services which are procured and described below:

The items 1, 5 and 6 have to be delivered within 60 days and the items 2, 3 and 4 within 90 days at Sukkur, New Sukkur, Rohri, Shikarpur, Khairpur and Larkana (all situated in North Sindh), respectively after contract signature. Refer to Bidding Documents, Section 6, Delivery and Completion Schedule. The tender includes also training for operating staff, to be held in each of the cities, and the bidder has to provide training for the bids they will offer in all cities.

3. Bidders, a single entity or joint venture, must meet the following requirements:
 - (i) An average annual turnover over the last 3 years of 4 million USD.
 - (ii) Completed at least two contracts of similar size and nature within the last two years, the value of the contracts must be minimum of 1,500,000 USD.
 - (iii) With his bid, nominate a sales and service point in the Province of Sindh (preferably in Sukkur) for the offered equipment/trucks brand which can provide the required regular services.
 - (iv) Goods of similar nature and complexity must have been in the bidder's production/ scope of trade for at least five years and a minimum of 25 tractors with tripping trolley, 25 wheel excavators, 25 Dumper trucks, 25 trucks with mounted back crane, 25 sucker machine and 25 jetting machines of similar specification have been sold by the bidder and must have been in operation satisfactorily for at least three years. The bidder shall also provide satisfactory operational certificates for the last three years from clients/utilities.
 - (v) To be awarded a contract, the bidder or its supplier/manufacturer must demonstrate at least 5 years experience in manufacturing of similar types of goods/equipment with the same or higher capacity. The bidder shall also provide satisfactory operational certificates for the last three years from clients/utilities.

- (vi) Bidders have to submit audited balance sheets and income statements for the last three years to demonstrate the current soundness of the financial position and its prospective long-term profitability. As a minimum, a Bidder's net worth calculated as the difference between total assets and total liabilities should be positive.
 - (vii) To be qualified for this contract, a Bidder has to demonstrate its access to liquid assets, lines of credit, and other finances in the amounts of 1,500,000 USD.
 - (viii) A bidders pending claims, arbitration, or other litigation shall represent in total not more than 60% of the Bidder's net worth.
4. International competitive bidding will be conducted in accordance with ADB's Single Stage: Two-Envelope procedure and is open to all Bidders from eligible source countries.
 5. Interested eligible Bidders may obtain further information or may collect the bidding documents from NSUSC at the address given below during office hours on all working days.
 6. The Bidding Document, in the English language, may be purchased by interested Bidders on the submission of a written application to the address below and upon payment of a non-refundable fee PKR 10,000 or USD 120. The method of payment will be Bank Transfer, bank details given below. The document will be sent by mail after the submission of the evidence of the bank transfer or can be collected personally at the address below. No liability will be accepted for loss or late delivery.
