- 7. 2% Earnest Money / Call Deposit of bid amount in form of pay order of any schedule bank in favour of CDGK enclosed with the tender shall be retained till expiry of the bid validity period / finalization of the case, which ever is earlier.
- 8. Canvassing in connection with tenders is strictly prohibited and tenders submitted by those contractors who are reported canvassing will be liable for rejection.
