
TENDER NOTICE

Tenders are invited to the supply of 50 kg Polypropylene woven bags manufactured from Prime Virgin material as per specification and details given below:

PARTICULARS	QUANTITY IN BALES OF 1000 BAG EACH	DELIVERY PERIOD
Description: Tubular woven poly propylene bags manufactured from Prime Virgin material with hemmed bottom and heart cut mouth ends made of Ultra Violet Stablished Polypropylene or with Ultra Violet Stabiliser mixed with polypropylene for packing of wheat	Polypropylene Woven bag for total quantity of 10.0 Million (P.P.) bags	Upto 15-03-2011 or earlier.
Size	Outside width: 59 Cm(23) ± 1.5 cm/ ± 0.5 Outside length: 100 cm (39) ± 1.5 cm/ ± 0.5	
Weave	11 Tape x 11 Tape per inch.	
Weight	115 Grams. $\pm 5\%$	
Capacity	50 kgs wheat grains	
Colour	Beige colour with green stripes of 2" horizontal band to run length-wise on both sides of the bag. "PB SINDH FOOD DEPTT 2011"	
Bottom Seam	The bottom of the bag should be folded once and sewn. The width of the fold should be 2.54 cm(1").	
Stitching	Acid resistant thread of Nylon or Polypropylene of 1000 denier should be used. Chain stitch should be used for sewing with at least 4 stitches per inch. The stitching should be uniform without any loose thread or knot.	
Drop Strength	The bags filled with 50 kgs. Wheat should be able to withstand without bursting at least 6 drops from a height of 16 feet when dropped flat.	
Printing	Printing design as proved will be printed on one side of the bag in single colour	
Printing Ink	Non-fading acid resistant ink should be used.	
Packing	1000 bags in one bale, wrapped in new polypropylene woven fabrics.	
Horizontal Band	2-inch Horizontal band is to run lengthwise on both sides of the bag as described by the purchaser.	

1. The Tenderers may quote for full quantities or for lesser quantities at their option clearly stating quantities for delivery: (a) ex-stock (immediate) & (b) within the periods specified against each item.
2. Tenders may be submitted in the prescribed forms as per conditions of tender enquiry available from the Section Officer (Wheat) Food Department Government of Sindh, 4th Floor, Sindh Secretariat No. 1 Karachi on payment of Rs.2000/- per set (non-refundable) through Challan.
3. The Bidders are required to submit earnest money @ 2.5% of the amount of their offer in the shape of Pay order in favour of Secretary Food, Government of Sindh. Tenders not supported by earnest money will not be entertained.
4. The quantity can be increased or decreased as per SPPRA Rules 2010 without assigning any reason.
5. The successful bidder in addition to the bid security shall submit security deposit in shape of Pay Order or Bank Guarantee valid upto 3(Three) months after completion of Contract in favour of Secretary Food Sindh to the tune of 2.5% of value of Contract.
6. The Bidders are required / follow the Clause of Sales Tax as defined in the existing Rules.
7. Last date for submission of tender is 10-02-2011 upto 1.00 P.M. The Tender will be opened on the same day (Technical Proposals at 2.00 P.M. & Financial Proposal at 3.30 p.m.) in the office of the Secretary, Food Department, Government of Sindh, 4th Floor, New Sindh Secretariat No.1 in presence of the Bidders or their representatives.
8. No tender form will be issued on the day of opening of tender.
9. Tenders submitted by firms other than manufacturer's must be accompanied by manufacturer's certificate. Tenders submitted without such certificate will not be considered.
10. The importer will quote their rates on FOR basis upto consignee end in local currency.
11. Prices quoted shall be inclusive of all taxes, duties including Octroi, Sales Tax etc up to Consignees end.
12. The evaluation of bid shall be on single stage two envelop procedure of SPPRA-2010 (Details is given in bidding document).
13. They shall submit separately, Financial and Technical proposals alongwith offer.
14. The successful Bidder shall be liable to affix adhesive stamp on the agreement at Rs 0.3% of the value of the Contract.
15. The Bidder should be registered with the Sale Tax Department and should enclosed a copy of the Registration along with Tender.
16. The Bidder shall be required to provide five samples of the product duly sealed and signed along with their offer.
17. The purchaser reserves the right to reject any or all of the offers as per provision of SPPRA Rules.
