 Sindh Education Reform Programme (SERP)

- The District Officer Education Works near Government Boys Pilot Secondary High School Dadu has received a loan/grant/credit/fund from the Donor/Government to be applied towards the Repair and Rehabilitation of Primary Schools Works (Construction of Shelter-less Primary Schools and missing facilities, Additional Class rooms) and intends to apply the funds to cover eligible payments under the Contract for four Taluka wise projects. Bidding is open to all bidders from eligible source countries as defined in Part One (Fixed) of the Bidding Documents For National Competitive Bidding: Procurement of Works - Smaller Contracts containing the Conditions of Contract as per Sindh Public Procurement Rules Ordinance 2010 (SPPRA)
- The District Officer Education Works Dadu near Government Boys Pilot Secondary High School Dadu under Sindh Education Reform Programme (SERP TOP-III) & (ELD) Government of Sindh invites sealed bids from eligible bidders for following works.

Bidding documents (and additional copies) may be purchased from the office of District Officer Education Works near Government Boys Pilot Secondary High School Dadu for a non-refundable fee of **Rs.3,000/-** in favour of District Government (Or Departments account should be mentioned) for each set. Interested bidders may obtain further information at the same address.
4. Bids shall be valid for a period of 35 days after Bid opening and must be accompanied by bid security of 3% in the shape of call deposit in the name of District Officer Education Works Dadu from any Scheduled Bank of Pakistan at the time of receiving of tenders on 4<sup>th</sup> March, 2011 at 12:00 noon which will be opened on the same day at 1:00 pm in the presence of tender opening / evaluation committee and the bidders or their authorized representative who wish to be present.
5. All bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish through post-qualification whether the bidder is qualified to perform the work.
6. Bids are required to be submitted on item rate basis (not on the basis of Composite Schedule of Rates with percentage premium) and the rates and amounts (in Rupees) must be filled by the bidder for each item in the Bill of Quantities and provide a total price. Noncompliance may result in rejection of bid.
7. Bidders should give their best and final price in their bids as no negotiations are expected.
8. As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion/pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract funded by the Government.
9. The Competent Authority reserves the right to reject any or all tenders subject to relevant provisions of SPPRA Rules, 2010;
10. If any of the information furnished by the contractor / firm proves to be false at any stage, the contract, even if awarded, is liable for cancellation and other actions, legal and otherwise, will be taken against the contractor / firm;
11. In case of any dispute regarding any step or stage of contract, a detailed dispute resolution mechanism is given in SBD.
12. For any other requirement please refer bid document.

Tenders if could not be opened on the due date either will be opened on the next day or another convenient date in case the undersigned is out of headquarter.
