2. The tenders will be received back on 24.02.2011 upto 1.00 PM and opened on the same day at 2:00PM in the presence of tender opening/evaluation committee and the bidder or their authorized representatives who wish to be present.

4. Eligibility conditions for intending participants are as under:-

 - c. Bio-Data of Technical staff employed and to be made available for working on the project.

 - g. Finance stability certificate issued by a scheduled Bank.
 - h. Affidavit in which the bidder undertakes that it is not involved in any litigation or abandoned any work in the department.

 - j. Affidavit that the bidder has not been black listed by any Government /Semi Government/ Autonomous body.


