

NOTICE FOR INVITING TENDERS

Sealed Tenders are invited from the interested bidders meeting the eligibility criteria of "Sindh Public Procurement Regulatory Authority (PPRA) Rules 2010 for Federal funded and UNICEF funded scheme National MNCH Program Sindh respectively at

- i. Renovation of CMW School / Hostel at DHQ Hospital Mithi
 - ii. Repair / Renovation of Day care centre including supply of furniture at THQ Hospital Hala
 - iii. Repair / Renovation of Day care centre including supply of furniture at Nursing Hostel Shaheed Benazir abad
1. The blank tender forms can be had from the office of the Provincial Program Director "National MNCH Program Sindh". Women Resource Centre, Ground floor, Kalapul, Near Naval Heights, Karachi, from Project Engineer from 10th February, 2011. The tender can be seen on web sites of Govt. of Sindh & Sindh PPRA, www.sindh.gov.pk, www.ppprasindh.gov.pk respectively.
 2. The last date of receipt of Tender is 28 - 02 - 2011 up to 1:00 PM and will be opened on same day at 2:00 PM in the presence of tender opening / evaluation committee and the bidders or their authorized representatives who wish to be present.
 3. If due to unavoidable circumstances, the undersigned is out of head quarters, or in case the tenders are cancelled / rejected or un responded, the next date for issue and opening will be as under:
 - a. Issue 28 - 02 - 2011 and opening on 01 - 03 - 2011 up to 1:00 PM.
 - b. Issue 01 - 03 - 2011 and opening on 02 - 03 - 2011 up to 1:00 PM.
 4. Eligibility conditions for intending participants are as under:
 - a. Full name of the firm along with organizational structure and permanent address with telephone number.
 - b. Details of works executed by the contractors in the past ten years indicating scope of works, estimated cost and time taken for completion duly certified by the concerned officials.
 - c. List and location of equipments, transport and machinery available with the contractor for this job.
 - d. Affidavit that the contractor has neither been black listed by any agency nor involved in any subversive activities.

- e. Copy of fresh enlistment letter of Pakistan Engineering Council in C-4 or above category and authenticating the works of such amount carried out in building nation department.
- f. Bio-data of the technical staff permanently employed and available with the firm/contractor for this project.
- g. List of cases entered into arbitration/Litigation. If not involved then affidavit to the effect that the firm /Contractor was not involved in any litigation, no work was rescinded in the past.
- h. List of work where penalty is involved, if any.
- i. Any additional information the applicant may like to furnish in support of its paper.
5. The earnest money specified should be in the name of Provincial Program Director National MNCH Program Sindh" in the shape of call deposit ie 2% of bid amount from any scheduled bank and must be attached with sealed bid documents, otherwise it will not be entertained.
6. The bidding will be two envelope system i.e. technical proposal and financial proposal separately.
7. If firm / partner involved in partnership deed, then complete details / instructions and power of attorney will be submitted in affidavit by the proprietor.
8. Conditional and Telegraphic tender will not be entertained.
9. The PEC, C-4 Category or above will apply for any work.
10. The Procuring Agency may reject all or any bids subject to the relevant provisions of SPPRA Rules 2010.
