## NOTICE INVITING TENDER

- The District Officer, Education Works, Works & Services Department, Sukkur, has received a loan/grant/credit/fund from the donor/government to be applied towards the Rehabilitation of School Works (Construction of Shelterless Primary School and Missing Facilities, Additional Classrooms) and intends to apply the funds to cover eligible payments under the contract for Taluka based projects. Bidding is open to all bidders from eligible source as defined in part one (FIXED) of bidding documents for National Competitive Bidding Procurement of Works – small contractors containing the condition of contract.

- Bidding documents (and additional copies) may be purchased from the Office of District Officer, Education Works, Works & Services, Sukkur, for a non-refundable fee of Rs. 3000/- in shape of Call Deposit in favour of District Government (or Department's Account should be mentioned) for each set. Interested bidders may obtain further information from the same address.
- The bids shall be valid for a period of 35 days after bid opening and must be accompanied by bid security 3% in shape of Call Deposit in the name of District Officer, Education Works, Works & Services, Sukkur, from any scheduled Bank of Pakistan at the time of receiving and opening of tenders on the dates mentioned as under: at 1:00 pm in the presence of Tender Opening / Evaluation Committee Sukkur comprising District Coordination Officer Sukkur, the Executive District Officer Finance Department Sukkur, the Executive District Officer, Works & Services Sukkur, the District Officer Education Works Sukkur and the Divisional Accounts Officer of this office and the bidders or their authorized representatives who wish to be present...
- All bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish through post qualification whether the bidder is qualified to perform the work.
- Bids are required to be submitted on item rate basis (not on the basis of composite schedule of rate with percentage premium) and the rates and amount (in rupees) must be filled by the bidders for each item in the Bill of Quantities and provide a total price. Non-Compliance may result in rejection of bid.
- In case of dispute, resolution mechanism will be as per SPPRA Rules 2010.
- As provided in the bidding documents, bidders engage corrupt or fraudulent practices (including collusion / pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract funded by the Government.
- The tenders will be issued to those bidders who possess 10 years experience in the building works, such certificate of Works & Services Department is required to be attached with the application of bidder.
- Application demanding for tenders must be supported with the complete profile of technical works executed previously and financial documents for security.
- The Competent Authority reserves the right to reject any or all tenders subject to the relevant provisions of SPPRA Rule 2010.
- For any other requirements please refer bid documents.
- If any of the information furnished by the contractor/firm proves to be false at any stage, the contract, even if awarded, is liable for cancellation and other legal action and otherwise will be taken against contractor/firm.
