  - vi. All the contractors / Firms having produced Pakistan Engineering Council Certificate for the current year may be allowed to participate in the tenders after submitting Solvency certificate and other required document as per PPRA rules.

5. Under Taking on affidavit that firm is not involved in any litigation or abandoned any work in the department.
6. The bidders should submit earnest money as shown against each work in shape of call deposit prepared from the scheduled bank in favour of the undersigned.

8. Affidavit with effect that all documents / particulars / information furnished are true correct.
