- The Tender Document can be obtained from the Office of the Director, On farm water management, Sindh, Hyderabad, against the written request with a Pay Order / Demand Draft of Tender Cost amounting to **Rs: 2000.00,** (non refundable), in favour of Director On farm water Management, Sindh, Hyderabad, on all Working Days upto 26-02-2011, during office hours.
- The Bidding Shall be on **Single Stage, Two Envelope** Procedure, First Envelope should contain **Technical Proposal** only & be clearly marked as "**Technical Proposal**" the Company Profile providing all the information detailed in the Tender Documents should compulsorily be enclosed in the envelop of "**Technical Proposal**".
- Second Envelope should contain **Financial Proposal (Rates)** along with the **Bid Security** @ **2%** of the **Quoted Rates** in the shape of Pay Order / Demand Draft (Refundable to Unsuccessful Bidders) and the Envelope be clearly marked as "**Financial Proposal**".
  - Both Envelopes should be sealed separately and placed in the **Third Envelop.** The **Name** of the **Bidder** be clearly marked on all the Envelops.
