3. The time for supply of required items has been fixed for 15 days after issuance of supply order.
4. The procuring Agency may reject all or any bid or proposals at any time prior to acceptance of a bid or proposal, subject to the relevant provision of SPPRA Rules.
5. The purchase committee may decrease or increase the number of items required in the light of SPPRA rules.
