Bidding documents (and additional copies) may be purchased from the office of District Officer Education Works near Government Boys High School No.1 Umerkot for a non-refundable fee of Rs.1,000/- in favour of District Government (Or Department account should be mentioned) for each set. Interested bidders may obtain further information at the same address.
4. Bids shall be valid for a period of 35 days after Bid opening and must be accompanied by bid security of 3% in the shape of call deposit in the name of District Officer Education Umerkot form any Scheduled Bank of Pakistan at the time of receiving and opening of tenders on the dates mentioned, which will be opened on the same day at 1:00 pm in the presence of tender opening / evaluation committee and the bidders or their authorized representative who wish to be present.
5. All bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish through post – qualification whether the bidders is qualified to perform the work.
6. Bids are required to be submitted on time rate basis (not on the basis of Composite Schedule of Rates with percentage premium) and the rates and amounts (in Rupees) must be filled by the bidder for each item in the Bill of Quantities and provide a total price. Noncompliance may result in rejection of bid.
7. In case of dispute, dispute resolution mechanism will be as per SPPRA rules 2010.
8. As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion/pooling) will be declared ineligible, either indefinitely or for a stated period of time. To be awarded a contract funded by the Government.
9. Tenders will be issued to bidders who possess ten years experience in the buiding works such certificate of works & Services departmet is required to be attached with the application of bidders.
10. Application demanding for tenders must be supported with the complete profile of technical works executed previously and financial documents for scrutiny.
11. The competent Authority reserves the right to reject any or all tenders subject to relevant provisions of SPPRA Rules, 2010;
