- 3 Bidding documents (and additional copies) may be purchased from the office of District Officer Education Works Jamshoro near irrigation workshop kotri for a non-refundable fee of Rs.1,000/- in favour of District Government (Or Departments account should be mentioned) for each set. Interested bidders may obtain further information at the same address.
- 4 Bids shall be valid for a period of 45 days after Bid opening and must be accompanied by bid security of 3% in the shape of call deposit in the name of District Officer Education Works Jamshoro from any Scheduled Bank of Pakistan at the time of receiving and opening of tenders on the date mentioned as under District Officer Education Works Jamshoro Opposite Irrigation Works Kotri at 01:00 pm in the presence of tender opening / evaluation committee and the bidders or their authorized representative who wish to be present.
- 5 All bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish through post-qualification whether the bidder is qualified to perform the work.
- 6 Bids are required to be submitted on item rate basis (not on the basis of Composite Schedule of Rates with percentage premium) and the rates and amounts (in Rupees) must be filled by the bidder for each item in the Bill of Quantities and provide a total price. Noncompliance may result in rejection of bid.
- 7 In case of any dispute regarding any step or stage of contract, a detailed dispute resolution mechanism will be as per SPPRA rules 2010.
- 8 As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion/pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract funded by the Government
- 9 Tender will be issued to bidder who passe 10 year experience in the building works such certificate of Works & Services Department is required to be attached with the application of bidders.
- 10 Application demanding for tenders must be supported with the complete profile of technical works executed previously and financial demand of scrutiny.
- 11 The Competent Authority reserves the right to reject any or all tenders subject to relevant provisions of SPPRA Rules, 2010
- 12 For any other requirement please refer bid document.
- 13 If any of the information furnished by the contractor / firm proves to be false at any stage, the contract, even if awarded, is liable for cancellation and other actions, legal and otherwise, will be taken against the contractor / firm; Bidders should give their best and final price in their bids as no negotiations are expected.
