4. In case the date of opening is declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the same time as mentioned.

5. The total bid amount as well as the rates of items must be filled both in figures and words and in case any correction is made by the contractor himself then each

correction must be initialed by the contractor; otherwise the tenders are liable to be summarily rejected.

6. The eligibility criteria for the bidders shall be as under:-

a) Particulars of the Engineer and Technical Staff working with the Firm.

b) Documentary evidence regarding under completion/completed works along with satisfactory completion certificate from the concerned department.

e) List of on going work with details and work order.

d) List of available machinery/equipments with documentary evidence regarding ownership.

e) Bank statement for last 3 years.

f) NTN Certificate from Income Tax Department with copy of CNIC

g) Affidavit to the effect that the firm is not involved in any court case and that no

work has been left by the firm incomplete.

h) Certificate from Registrar of Companies with Memorandum of Articles & Association in case the firm are a Private Limited Company, Registered Partnership Deed in case the firm is run by Partners and an Affidavit in case the firm is owned by a sole proprietor.

7. The bidder are required to submit the above information along with their bids

8. If any fake documents are found then the tender is liable to be rejected/cancelled with out any compensation but with penalty as per rules.

9. Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who are reported to be involved in canvassing will be liable for

If a bidder submits a seriously unbalanced bid then if deemed necessary, the procuring agency may require him to deposit extra performance security to a level sufficient to protect the procuring agency against financial loses, failing which the submitted bid security will be forfeited by the procuring agency.

been signed with the successful bidder or the validity period has expired.
