The companies / firms having adequate experience / expertise and registration in relevant category of work (civil works specially underground water tanks in the Desert areas) with PEC are required to furnish their bids, which shall comprise a **Single Stage - Two Envelope Procedure**. Each envelope shall contain separately the financial proposal and the technical proposal, shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion. The firms, which are found technically sound would only be considered for participation in the financial bidding. Non compliance will be considered ineligibility and disqualification. The technical proposal should contain following information:-

- a) Company profile with financial status for the last five years.
- b) Proven track record in the relevant field.
- c) List indicating no. of equipments and other allied machinery required for these works available with firm
- List of technical manpower / consultants on their payroll with relevant field experience for execution of work
- Details of the projects undertaken, under execution / negotiations.
- Reference of similar works along with execution certificate
- A certificate to the effect that firm has never been blacklisted by any Government Agency or in litigation anywhere in Pakistan or abroad.

CONDITIONS:

- The application for purchase of Tender Documents should accompany with their respective Tender Fees (Non Refundable) in shape of Pay Order from any of the scheduled Bank pledged to the Director General, Sindh Coal Authority during office hours to Sindh Coal Authority upto
- 2. The Technical, as well as, Financial Bids in sealed envelopes accompanied by bid security @ 2% of bid price in the form of bank draft/pay order in favour of Director General, Sindh Coal Authority should reach the office of undersigned on 24th March, 2011 at 1300 hrs. Initially, only the envelope marked "TECHNICAL PROPOSAL" shall be opened on same day at 1330 hrs in presence of participating bidders. Financial proposal of bids found technically qualified shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance.
- The successful Contractor whose tender(s) are accepted will have to obtain adhesive stamps from Assistant Superintendent Stamps, Government of Sindh, Karachi on payment of stamps fee according to schedule prescribed in the Sixth Finance Act 1996 amended rules up to date and sign the agreement.

 Structural design will be got done by the Lowest Bidder & Vetted by Competent Authority whose decision will be final, for which no payment will be made separately.

 Conditional tenders will not be accepted. The Procuring Agency may reject all or any bid subject to the relevant provisions of Sindh Public Procurement Rules, 2010.

NOTE: In case of non-response, tenders will be re-issued on 25.03.2011 and opened on 30.03.2011.
