- 2 The tendr documents will be issued to the contractor on submission of written request on letter head alongwith original documents with their photo copies as mentioned above and on payment of non-refundable cost of tender price through pay order from any schedule Bank in favour of CDGK. Bid Security in shape of pay order from any schedule Bank in favour of CDGK as mentioned above should be enclosed with the bid otherwise the tender will be rejected No tender will be sold after the date of sale as mentioned above.
- In case of any reason, if the tenders are not responded on the above dates, the next date of submission and opening will be 4 4 2011 and the tender documents will also be available for sale upto 2-4-2011.
- 4 In case, the date of opening or last date of sale is declared as a public holiday by the Government, the next official woring day shall be deemed to be the date for last date of sale or submission and opening of tenders (as the case may be). The venue & time will remain same.
- 5 The total bid amount as well as the rates of items must be filled both in figure and words and in case any correction is made by the contractor himself then each correction must be initiated by the Contractor, other wise the tenders are liable to be summarily rejected.
- 6 Minimam Qualification/Eligibility Criteria checked during opening process of tender & if any one is missing then the tender summarily rejected at the moment by the tender opening committee.
 - I) Bid Security as mentioned in the NIT & Bidding Documents is furnished.
 - ii) All rate quoted including the total amount of the bid shall be in figures & works(both)
 - iii) All corrections/overwriting shall be clearly re-written with initials & duly stamped by the bidder.
 - iv) The bid shall be properly signed,named & stamped by the authorized person of the firm and authorization letter for signatory shall be enclosed with the tender by the authorized person.
 - v) Evidence of employing and Engineer as declared in the PEC Licence should be provided in shape of copy of Engineer's Registration certificate by PEC. Bank Statement showing the name and amount of the monthly slary of the Engineer/paid copy of the Income Tax challan in the name of the Engineer of the salary in taxable.
 - vi) Bank certificate(original)in respect of financial capability/credit limit of the bidder not less than 30% of the bid amount issued on or after 15-3-2-2011 should be produced.
 - vii) The evidence of ownership/lease of at least 03 Nos, road construction Machinery out of Tractor, Grader, Roller, Dump Truck, Concrete Mixture, asphalt plant & its allied equipment(at least 3 Nos)to the bidder.
 - viii) The minimum turn over/work experience with satisfactory completion report in last 2 years should be equal to the work cost in which bidder interested to participate.
- 7 The joint venture between two or more firms is allowed subject to compliance of conditions of stipulated rules of PEC.
- 8 If any fake documents are found at any stage then the tender is liable to be rejected/cancelled with out any compensation and with penalty as per rules.
- 9 Canvassing in connection with tenders is strictly prohibited and the tenders submitted by the contractors who are reported canvassing will be liable for rejection.

- If a bidder submits a seriously unbalanced bid then he may be required to deposit extra performance security to a level sufficient to protect the procuring agency against financial losses, failing which the submitted bid security will be forfeited by the procuring agency.
- Bid security of the unsuccessful bidder shall be released once the contract has been finilized with the successful bidder or the validity period has expired.
