- The Bid Security as mentioned above in shape of pay order in favour of CDGK shall must be enclosed with tender documents without which the tender will be treated as cancelled.

4. The contractor must mention their complete and correct present postal address in tender documents & quote the rates both in words & in figures. Incomplete / Conditional tenders will be not accepted.
5. The tender documents can be had from the office as mentioned above on any working day during office hours except the date of opening.
6. All the tender shall be dropped on as per above Schedule up to 02:00 p.m and will be opened by the Tender Opening Committee in the office of Administrator, TMA Lyari, Karachi, at 02:30 p.m in presence of the contractor who wish to be present.
7. In case the date of opening declared as a public holiday by the Government, or non working day due to any reason the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.
8. In case of any reason, if the tenders are not responded on the above dates the next date of submission and opening will be 03-04-2011 and the tender documents will also be available upto 04/04/2011.
