The **Government of Sindh (GoS), Islamic Republic of Pakistan** has received a loan from the Asian Development Bank (ADB) towards the costs of the Sindh Cities Improvement Investment Program (SCIP). Part of this loan will be used for payments under the contract named above. Bidding is open to bidders from eligible source countries of the ADB.
2. The **North Sindh Urban Services Corporation (NSUSC) Limited** ("the Employer") invites sealed bids from eligible bidders for "Skip Platforms for Solid Waste Collection". The aim of this project is to upgrade the existing solid waste collection system in the following six cities of North Sindh: **Sukkur, New Sukkur, Rohri, Khairpur, Larkana and Shikarpur**. All six cluster towns are situated within 100 kilometers of Sukkur, which is the largest of them and a commercial hub, situated on the right bank of the River Indus, adjacent to the Sukkur Barrage spanning the River Indus.
3. Only eligible bidders with the following key qualifications should participate in this bidding:
 - Bidders must prove experience in the role of contractor, subcontractor, or management contractor for at least the last 5 (five) years. The criterion to be met by each partner of a Joint Venture.
 - Bidders must have participated as contractor, management contractor, or subcontractor, in at least 2 (two) contracts, successfully or are substantially completed and similar to tendered works, within the last 5 (five) years, each of a value of at least PKRs 20 million. The criterion has to be met by all partners combined in the case of Joint Venture.
 - Bidders must further prove experience in the following key activities, performed on contracts during the last 5 (five) years: "Construction of Pre-fabricated Reinforced Concrete Elements". The criterion has to be met by all partners combined in the case of Joint Venture.
 - Bidders must submit financial statements acceptable to the Employer, for the last 3 (three) years to demonstrate the soundness of the applicant's financial position.
 - Bidders must have a minimum average annual construction turnover of Pak Rs. 90 million, calculated as total certified payments received for contracts in progress or completed, within the last 3 (three) years. These rules apply for all partners combined in the case of Joint Venture.
 - The Bidder must demonstrate ownership or access to the following key equipment:
 - i. Plant to produce prefabricated concrete elements
 - ii. Truck with mounted crane
 - The Bidder must demonstrate that it has the personnel for the following key positions meeting the following requirements: i) A team leader with engineering degree and related working experience of not less than 15 years, fluent in written and spoken English and 10 years experience on similar jobs ii) A plant manager with minimum 10 years working experience and 5 years experience in similar works iii) 02 Supervisor for Environmental Compliance with minimum 03 years similar experience and iv) a foreman with minimum 10 years working experience and 5 years experience in similar works .
