

  - d) List of available machinery/equipments with documentary evidence regarding ownership.
  - e) Bank statement for last 3 years.
  - f) NTN Certificate from Income Tax Department with copy of CNIC
  - g) Affidavit to the effect that the firm is not involved in any court case and that no work has been left by the firm incomplete.
  - h) Certificate from Registrar of Companies with Memorandum of Articles & Association in case the firm are a Private Limited Company, Registered Partnership Deed in case the firm is run by Partners and an Affidavit in case the firm is owned by a sole proprietor.
