- vi) NTN certificate from Income Tax Department with copy of CNIC.
- vii) Affidavit to the effect that the firm is not involved in any court case and that no works has been left by the firms incomplete.
- viii) Certificate from Registrar of Companies with Memorandum of Articles and Association in case the firm are a Private Limited Company, Registered partnership Deed in case the firm is run by partners and an affidavit in case the firm is owned by a sole proprietor.
