2. All the contractors' suppliers and interested persons shall submit the 3% of the total quoted cost as bid security at the time of submission of bids/ tender forms in shape of pay order infavour of undersigned in a sealed envelop.
3. The time for supply of required items has been fixed for 20 days after issuance of supply order.
4. The procuring Agency may reject all or any bid or proposals at any time prior to acceptance of a bid or proposal, subject to the relevant provision of SPPRA Rules.
5. The purchase committee may decrease or increase the number of items required in the light of SPPRA rules.
6. The purchase committee may relax any condition of contract.
7. The tender who does not fulfill the terms and conditions will not be entertained.
8. The Government notified black listed contractors suppliers/persons shall not be entertained.
9. The contractor's suppliers/persons will have to execute an agreement on stamped paper to the effect that he has accepted the conditions of contract and he has not been black listed by any Government/Semi Government / Autonomous Bodies.
