- 2- The tender in sealed cover superscripted with the name of work should be dropped in the tender box kept in the office of the District Officer-II (E&M) & Health Institution, Room No. 306, 3rd Floor, Civic Center, Gulshan-e-Iqbal, Karachi, by 2:00 P.M on 10-05-11 and the same will be opened on the same day at 2:30 P.M in the District Officer-II Room of E&M & Health Institution, CDGK, Room No. 306, 3rd Floor, Right Wing, Civic Center, Gulshan-e-Iqbal, Karachi in presence of those bidders or their representatives who wish to be present.
- 3- In case of any reason, if the tenders are not responded on the above dates the next date of submission and opening will be 18-05-11 and the tender documents will also be available for sale upto 16-05-11 to 17-05-11.
- 4- In case the date of opening or last date of sale is declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the same time as mentioned above.
- 5- The total bid amount as well as the rates of items must be filled both in figures and words and in case any corrected is made by the Contractor himself then each correction must be initialed by the Contractor, otherwise the tenders are liable to be summarily rejected.
- 6- The eligibility criteria for the bidders shall be as under:

 - ii- Documentary evidence regarding under completion / completed works along with satisfactory completion certificate from the concerned department.

- iv- List of available machinery / equipments with documentary evidence regarding ownership
 - v- Copy of Electrical Valid License issued by Government of Sindh.
 - vi- Bank Statement for last 3 years.
 - vii- NTN Certificate from Income Department with Copy of CNIC.
 - viii- Affidavit to the effect that the firm is not involved in any court case and that no work has been left by the firm incomplete.
 - ix- Certificate from Registrar of Companies with Memorandum of Articles & Association in case the firm are a Private Limited Company, Registered Partnership Deed in case the firm is run by Partners and an Affidavit in case the firm is owned by a Sole Proprietor.
- 7- The bidders are required to submit the above information alongwith their bids.
- 8- If any fake documents are found then the tender is liable to be rejected / cancelled with out any contractors who are compensation but with penalty as per rules.
- 9- Canvassing in connection with tenders is strictly prohibited and tenders submitted by the Contractors who are reported canvassing will be liable for rejection.
- 10- If a bidder submits a seriously unbalanced bid then if deemed necessary, the procuring agency may require him to deposit extra performance security to a level sufficient to protect the procuring agency against financial losses, failing which the submitted bid security will be forfeited by the procuring agency.
- 11- Bid security of the unsuccessful bidders shall be released once the contract has been signed with the successful bidder or the validity period has expired.
- 12- The procuring agency may reject all or any bid subject to the relevant provisions of SPPRA Rules 2010.
