All information and relevant data in respect of tenderers/bidders and their bids/quotation should be provided in the format mentioned below:-

- EARNEST MONEY: All firms whether registered or un-registered shall have to provide order or Bank Draft. Cash or Cheque (Bearer/Crossed) will not be entertained.
- Original purchase receipt of tender documents must be enclosed along with the offer/bid, otherwise offer will not be entertained.
- The store is required as locally available and therefore required to be quoted in local currency i.e. Pakistan Rupee.
- The validity of the offered rates should be atleast sixty (60) days from the date of opening of tender.
- 10. The successful tenderers/bidders will have to enter in a written contract with the S.O.(B), Special Initiatives Department, before initiating any supply of store and performing other related assignments. The agreement will be dully stamped at rate of Rs. 0.03 of contract amount.
- 11. The successful bidder is required to enter in aforesaid contract within a week's time after he/she being asked to supply the stores in the form of supply order/advance acceptance. The contract will be executed subject to furnishing a Security Deposit equivalent to 2.5% of the total value of contract, in case of registered firm and 15% of total value of contract, in case of un-registered firm in the form of call Deposit, Pay Order or Bank Draft. Cash or Cheque (Bearer/Crossed) will not be entertained. In case of failing to enter the contract within stipulated time, the supply order/advance acceptance will be treated as cancelled.
- 12. All supplies should be made within 30 (thirty) days. This delivery period will not be extended and tenderers/bidders who fails to deliver the store shall face forfeiture of their security deposit.
- 13. The stores are required to be delivered at the consignee's end i.e. S.O.(B), Special Initiatives Department.

SPECIAL CONDITIONS

1. Firms registered with the Directorate of Industries (Supply Wing) Government of Sindh Karachi shall furnish photocopy of their valid Registration/Renewal Certificate with the offer/tender.

2. Tender documents submitted by the respective tenderer/bidders should be properly sealed.

3. Tenderers/bidders are required to quote the rates separately against each item both in figures and words on their letterhead duly sealed and signed and not on tender

4. Stores are required to be delivered within 30 (thirty) days exactly in accordance with the terms and conditions illustrated in the CONTRACT. The bidders/tenderers shell, however, give specific date of their shortest guaranteed delivery period (in case different from that mentioned in tender documents/notice) by which the supply will be completed positively.

5. Tenders/bidders shall purchase separate tender documents and furnish cash receipt(s) for each alternate offer in case they want to submit alternate offer for any item(s). However, the choice to select/ignore any of the alternate offer(s) shall

rest with the purchaser.

Free installation/demonstration of store at consignee's end shall be confirmed be

the tenderer/bidder in his/her tender documents.

7. The supplier shall require to mention the exact and separate WARRANTY of the each and every item. Warranty of parts and service for 01 (one) year will at least be required with confirmation regarding availability of spare parts.

8. In case of Sole-distributor/Sole Agent, a certificate/authority letter in original from their PRINCIPAL(s) / ORIGINAL MANUFACTUREER (s) will be required to be provided by the tenderer/bidder to guarantee satisfactory performance, after sales services and availability of spare parts for item
