- Manufacturers, traders as well as importers are allowed to participate in the tenders. iii.
- The trader shall produce authenticated proof of source of supply alongwith tender and iv. relevant papers thereof.
- Bidders are allowed to offer any quantity. V.
- Bid Documents is available from the Office of Section Officer (W), Food Department, vi. Government of Sindh, Karachi and could be obtained against paid Challan of Rs.2000.00 per set in Government Treasury /State Bank of Pakistan (Non-Refundable) during office hours from the date of publication.
- The bidders are required to submit earnest money @ 2.5% of the amount of their offer in vii. the shape of Pay order in favour of Secretary Food, Government of Sindh. Tenders not supported by earnest money will not be entertained.
- The quantity can be increased or decreased as per SPPRA Rules 2010 without assigning viii.
- The successful bidder in addition to the bid security shall submit security deposit in shape ix. of Pay Order or Bank Guarantee valid upto 3(Three) months after completion of Contract in favour of Secretary Food Sindh to the tune of 2.5% of value of Contract.

- The bidders are required / follow the Clause of Sales Tax as defined in the existing Rules.
- Last date for submission of tender is 30-04-2011 up to 1.00 p.m. The tender will be Xi. opened on the same day at 2.00 p.m. in the Office of Secretary Food, Government of Sindh, New Sindh Secretariat Building No. 1, 4th Floor, Karachi in the presence of bidders or their representatives.
- In case of any exigency or holiday the Tender will be opened on the next working day. xii.
- No tender form will be issued on the day of opening of tender. xiii.
- The importer will quote their rates on delivered at consignee end in local currency. List of xiv. Consignees is attached with bidding document.
- Prices quoted shall be inclusive of all taxes, duties including Octori, Sales Tax etc up to XV. Consignees end.
- The evaluation of bid shall be on single stage two envelop procedure of SPPRA-2010 xvi. (Details is given in bidding document)
- The bidders shall submit separately, Financial and Technical proposals alongwith offer. xvii.
- The offers shall be firm, unambiguous and unconditional. xviii.
- The successful Bidder shall be liable to affix adhesive stamp on the agreement at Rs 0.3% xix. of the value of the Contract.
- The Bidder should be registered with the Sale Tax Department and should enclosed a XX. copy of the Registration along with Tender.
- The Bidder shall be required to provide two samples of the product duly sealed and xxi. signed along with their offer.
