# Contractors are liable to be summarily rejected. **Substantially Responsive Bids:-**

6. Only those bids, which comply with the each minimum qualification criteria attached with tender document, shall be declared substantially responsive bids at the time of tender opened and will be eligible for further evaluation, otherwise the same will be declared as non responsive / rejected.

7. The bidders are required to submit the above information, the singed evidence against evaluation criteria along with their bids. However joint Venture between two or more

firms is allowed subject to compliance of condition of stipulated rules of PEC.

8. If any fake documents are found then the tender is liable to be rejected / cancelled with compensation and with penalty as per rules.

9. Canvassing in connection with tender is strictly prohibited and tenders submitted by

contractors who are reported canvassing will be liable for rejection.

10. If a bidder submits a seriously unbalanced bid then he will be required extra performance security to a level sufficient to project the procuring agency against financial losses, failing which the submitted bid security will be forfeited by the procuring agency.
