5. The total bid amount as well as the rates of items must be filled both in figures and words and in case any correction is made by the contractor himself then each correction must be initiated by the contractor; otherwise the tenders are liable to be summarily rejected.
6. **Substantial Responsive Bid:-**  
Those bids, which comply each requirement of minimum qualification Criteria as provided in the Bidding Documents, are only eligible for further detail evaluation. The bids which did not comply all the minimum qualification criteria will summarily rejected.
7. The bidder is required to submit the above information, the signed evidence against evaluation Criteria along with their bids. Joint venture between two or more firms is allowed subject to compliance of PEC's rules and regulations.
8. If any fake documents are found then the tender is liable to be rejected/cancelled with out any compensation and with penalty as per rules.
